BIOGRAPHY

William N. Warren joined Kelly Hart in 1993. Mr. Warren is a partner and co-chairs the firm's Litigation practice group. He attended Baylor University, where he obtained his Bachelor of Arts in 1989, and Baylor University Law School, graduating with his Juris Doctor, *cum laude*, in 1993. Mr. Warren has considerable experience representing clients in state and federal courts in a broad range of complex civil litigation matters, including business torts, securities issues, construction claims, products liability, and fraud related lawsuits.

EXPERIENCE AND HIGHLIGHTS

- Lead trial counsel for plaintiffs in suit against defendant advisor and his affiliated company for breach of fiduciary duty, fraud, and professional negligence; obtained seven-figure jury verdict for actual and punitive damages, and final judgment imposing a constructive trust on company assets
